Upon issuance of required permits, construction may begin on your project and inspections conducted. Approved plans and a permit card must be on the job site during all phases of construction. At specified stages of the building process, the project inspections must take place to ensure that the project construction is going according to approved plans.

NOTE: *Inspections are conducted from 7:00 a.m. to 4:30 pm Monday - Friday. Inspections requested to be scheduled for specific times during the workday, outside normal work hours, on weekends, or holidays can be available at an extra charge. Please see the listing below for clarification on additional inspection fees. All of these inspections are scheduled by calling our Dispatch offices at (702) 229-6914. Fees can be found in Ordinance 6769 adopted with the City of Las Vegas Administrative Code, 2019 Edition.*

EXPRESS INSPECTIONS

Contractors can call in for same-day inspections, Epoxy Inspections or inspections scheduled for a specific time of the day. This optional service is available for additional fees of \$186.00 per hour with a one hour minimum (fee #35).

SPECIAL INSPECTIONS

Special inspections may be required during certain types of construction. The Engineer on the project and our Structural Plans Examiner will indicate when this is required and which inspections the City of Las Vegas can conduct. A Special Inspections agency may also be required on certain projects. The inspections done by the City of Las Vegas are at a cost of \$368 for a two-hour minimum (fee #84).

OVERTIME EXPRESS INSPECTIONS

Contractors can call our offices and make appointments for inspections to be scheduled after working hours (after 5:00 pm Inspections). This optional service is available for an additional fee of \$276.00 per hour with a one hour minimum (fee # 82). Additional time after one hour will be charged per rate.

CALLOUT INSPECTIONS

Contractors can call our offices and make appointments for inspections to be scheduled in the evenings, weekends and holidays. This optional service is available for an additional fee of \$421.00 for a three-hour minimum (fee # 83). Additional time after three hours is charged at the Overtime rate of \$276.00 per hour. Emergency after hours calls are also charged at the Callout rate of \$421.00.

HOLIDAY CALLOUT INSPECTIONS

Holiday Callout is an optional service for an additional fee of two Callouts at \$421.00 each (\$842) for a three-hour minimum (fee # 83). Additional time after three hours is charged at the Holiday Overtime rate of \$552.00 per hour.

INSPECTIONS REQUIRED WITH ELECTRICAL PERMITS

Panel Change-outs - Inspection Code- 240 (When the panel is being changed out), (Not affecting the Meter)

Service Change - Inspection Code - 231 (Change out the existing service, Same for Same and Service Upgrades, a meter tag will be issued)

Electrical Meter Repair & Tag - Inspection Code- 240 (Final Electrical), (Repair will include tampering, meter clip)

Meter Tag Only - Inspection Code - 240 (Final Electrical), (Restoring Power with no work)

PHOTOVOLTAIC PERMITS

Commercial installations: Inspection Code- 220 (Rough Electrical); Called prior to panel installation, so the inspector can verify the bonding and rail attachment to the roof; Inspection Code- 227 (Alternate Power Source) & 540 (Final Fire) when the project is completed.

Residential installations: Inspection Code- 227 (Alternate Power Source)

Inspection Code- 239 (Temporary Pole / Construction Power)
