AN AT-RISK LETTER SHALL ACCOMPANY THIS APPLICATION IF RETAINING WALLS ARE BEING APPLIED FOR PRIOR TO FINAL MAP RECORDATION. PLEASE NOTE, IN ORDER TO OBTAIN EARLY RETAINING WALLS AN EARLY GRADING PERMIT MUST BE ISSUED.
- ONE APPLICATION MUST BE SUBMITTED PER BLOCK WHEN REQUESTING PERMITS FOR MULTIPLE LOTS.
- A COPY OF THE APPROVED GRADING PLAN DETAILING LOCATION AND SIZE OF PROPOSED WALLS WHEN REQUESTING PERMITS FOR MULTIPLE LOTS.
- SEE STANDARD PLAN CRITERIA FOR SUBMITTAL REQUIREMENTS.
