# **GENERAL INFORMATION:**

# LVMC 6.95 - CANNABIS ESTABLISHMENTS

**LVMC 6.95.010** - By virtue of State legislation now codified in NRS Chapters 678A to 678D, cannabis-related establishments and services are authorized to conduct business within the State, subject to State and local regulation.

**LVMC 6.95.030** - It shall be unlawful for any person to operate any cannabis establishment in the City in any of the following circumstances:

- 1) Without a license duly issued by the State regulating authority;
- 2) Without a license issued pursuant to this Chapter; or
- 3) In violation of applicable state laws or this Code.

**NOTE:** In order to apply for a business license for a cannabis establishment (other than a laboratory or cannabis distributor), you must have a Special Use Permit (SUP) and state approval.

## Limited Liability Companies (LLC):

## **FEES:** (All fees are non-refundable)

#### **CLV Business Licensing Fees:**

- ☐ Initial Processing Fee: \$100.00
- License and Origination Fee: based on license category

Cannabis Cultivation Facility: \$20,000 Origination Fee for the first 5,000 Sq. Ft. and \$10,000 for each additional 5,000 Sq. Ft., or portion thereof, of approved cultivation area.

Cannabis Production Facility: \$5,000 Origination Fee.

Cannabis Dispensary / Adult-Use Cannabis Retail Store: \$75,000 Origination Fee.

Cannabis Independent Testing Laboratory: \$10,000 Origination Fee.

Adult-Use Cannabis Distributor (based inside City of Las Vegas): \$10,000 Origination Fee

Adult-Use Cannabis Distributor (based outside City of Las Vegas): \$100 Origination Fee.

\* All Cannabis Establishments (inside city limits) have a semi-annual renewal fee of 3%.

Temporary License Request (optional): \$500.00

Waiver Request Fee (if applicable): \$100.00 per person

## **LVMPD Suitability Fees:**

\$150.00 per person being investigated

\$200.00 per privilege license

#### **Notary Fees:**

If your items need to be notarized, a license technician can assist you with this during your appointment for an additional \$5.00 per signature.
