- Chart of related corporation (if applicable)

LIMITED LIABILITY COMPANIES (LLC)

- Articles of Organization
- Operating agreement
- List of members and contributions if not included in Operating Agreement
- File stamped copy of Certificate of Business Fictitious Firm Name** (Clark County Clerk, 200 Lewis Ave. or 500 S. Grand Central Pkwy.)
- Leased Location - properly executed lease agreement or proof of property ownership** (may be contingent on approval of license)
- Owned Property - Escrow instructions or copy of Assessor's record**

If born **IN** the United States or abroad to U.S. citizens provide one of the following:

- Certified copy of Birth Certificate
- Copy of Certification of Birth Abroad

If born **OUTSIDE** the United States or abroad to U.S. citizens provide one of the following:

- Naturalization Certification
- Copy of Permanent Resident Card
- Employment Authorization Card

- U.S. Military Discharge Form DD2214 or equivalent if served in another country (if applicable)
- 1 Current photo of head and shoulders (Passport size - approximately 2" X 2" - **Must be less than 6 months old**)
- Driver's license or state issued identification card

FEES (Checks must be made payable to the City of Las Vegas)

- Original License Fee: \$10,000.00
- Initial Processing Fee: \$100.00
- Suitability Fees:
 - \$150.00 per person/principal being investigated
 - \$200.00 per privilege license
- \$500 Temporary License Request Fee (if requesting a temporary license)
