- 1. I understand that it is <u>NOT</u> legal to operate, advertise, or engage in the sale of ice cream without a City of Las Vegas business license. (LVMC 6.47.020)
- 2. I understand that it is <u>NOT</u> legal to operate, vend, or ride in an ice cream truck without a valid work card. (LVMC 6.47.020)
- 3. I understand that I may <u>NOT</u> be issued a City of Las Vegas business license until the ice cream truck complies with all Health Department regulations and has a valid Health Permit. (LVMC6.47.050)
- 4. I understand that I <u>MUST</u> have, maintain, and provide to the City of Las Vegas proof of public liability and property damage insurance, to protect the public against any and all claims for damages for personal injuries, including death and against claims for property damages. (6.47.110) Such insurance shall be in minimum amounts of:
 - a. (\$100,000) for injuries, including death, to any one person.
 - b. (\$300,000) for injuries, including death, to more than one person on account of any one accident.
 - c. (\$25,000) in property damage coverage for each accident.
 - d. The insurance policy must list the City of Las Vegas as an additional insured party to the policy.
- 5. I understand that anytime the ice cream truck is operating for business, that <u>NO ONE</u> other than the driver and one additional employee may occupy or ride in the truck. (LVMC 6.47.120)
- 6. I understand that I <u>CANNOT</u> rent or lease my ice cream truck to an independent contractor and I cannot allow anyone else beside the owner and employee to operate the ice cream truck during business operations. (6.47.120)
- 7. I understand that I <u>CANNOT</u> sell any food that is not prepackaged, frozen ice cream, or soft-serve ice cream and that items such as **toys** or any **non-edible** products are <u>NOT</u> allowed. (LVMC 6.47.010 C)
- 8. I understand that <u>ANY</u> arrests or citations for any reason must be reported to the City of Las Vegas Business Licensing and the Las Vegas Metropolitan Police Department within 48 hours.
- 9. I understand that <u>NOT</u> telling the truth or failing to report any such incidents may result in my ice cream truck license being denied or revoked.
