ICE CREAM TRUCK AFFIDAVIT & TOY ADDENDUM

1. I understand that under Las Vegas Municipal Code 6.47.020, It is unlawful for a person to: Conduct, engage in, carry on, advertise or market an ice cream business without a license issued pursuant to this chapter; Drive an ice cream truck or vend from an ice cream truck without a valid work card issued pursuant to Las Vegas Municipal Code 6.86;

2. I understand that under to Las Vegas Municipal Code 6.47.050, No ice cream truck license may be issued unless the truck: complies with any certification requirements of the Health District and possesses evidence of current certification and compliance with Health District requirements;

3. I attest that I have the insurance required under Las Vegas Municipal Code 6.47.110, Each ice cream truck licensee must file with the Department proof of insurance with a licensed insurance company maintaining in full force at all times public liability and property damage insurance which shall protect the public against any and all claims for damages for personal injuries, including death and against claims for property damages which may arise out of or in connection with any operations or activities of an ice cream truck. Such insurance shall be in amounts of not less than one hundred thousand dollars (**\$100,000**) for injuries, including death, to any one person; subject to the same limit for each person in an amount of not less than three hundred thousand dollars (**\$300,000**) for injuries, including death, to more than one person on account of any one accident; and not less than twenty-five thousand dollars (**\$25,000**) in property damage coverage for each accident. **The insurance policy must list the City of Las Vegas as an additional insured party to the policy;**

4. I understand that pursuant to Las Vegas Municipal Code 6.47.120, Occupants of truck - Limitations: During any time that an ice cream truck is in operation for business, no one other than the driver and one additional person may occupy or ride in the vehicle. The driver and additional occupant, if any, must be either the licensee or an employee of the licensee. The above ordinance **prohibits** the renting of an ice cream truck to an independent contractor and **prohibits** the operation of the truck by any person who is not the licensee or a bona fide employee of the licensee. Las Vegas Municipal Code 6.47.020 (C) makes it unlawful for any person to vend from an ice cream truck or operate an ice cream truck for the purpose of vending unless that person without a valid work card. **It is the responsibility of the licensee to insure that any person operating an ice cream truck on the licensee's behalf has in his or her possession a valid work card.**

5. I further attest that any arrests or citations for any reason will be reported to business services and LVMPD-SIS in writing within 48 hours of incident.

6. I understand that failure to be truthful and/or failure to report any such incident(s) as required may result in my ice cream truck license and/or renewal being denied.

TOY ADDENDUM:

Las Vegas Municipal Code 6.47.010(C) defines Ice cream truck as follows:

"Ice cream truck means any motor vehicle which is required to be registered by the Nevada Department of Motor Vehicles and which is used to vend any of the following products, whether or not the truck carries other prepackaged food products: (1) Prepackaged frozen dairy or water-based food products; or (2) Soft-serve or hand-dipped frozen dairy or water-based products."

The above definition **prohibits** the sale of any non-food items such as **toys or trinkets**. I understand that if any non-food items are found in inventory on this truck disciplinary action will be taken against the above referenced license.
