



## **Marijuana Sales - Frequently Asked Questions**

### **1. Who can purchase retail marijuana?**

In order to purchase retail marijuana, you must be at least 21 years old and possess a valid government-issued identification.

### **2. Who can sell retail marijuana to a consumer?**

In the city of Las Vegas, there are currently 12 licensed retail marijuana stores authorized to sell retail marijuana. Only those licensed as medical marijuana dispensaries were allowed to apply for a retail marijuana store license.

### **3. Where can I purchase marijuana if I don't have a medical registration identification card?**

If you are at least 21 years old and have a valid government-issued identification you may purchase marijuana from any licensed retail marijuana store in Nevada.

### **4. May I request a private consultation so I can ask questions and obtain information about the products?**

Yes, the retail marijuana store must accommodate a customer's

request for a confidential and private consultation within the available space of the store.

### **5. How much retail marijuana can I purchase or possess at one time?**

The maximum amount that a person can purchase or possess at one time is one ounce of marijuana or one-eighth of an ounce of concentrated marijuana.

### **6. Now that retail marijuana is legal, can I consume marijuana anywhere?**

Marijuana cannot be consumed or smoked in any public place, including parks, sporting events, moving vehicles, casinos, hotels, concerts, festivals, marijuana facilities or while you're walking down the street. People are not permitted to smoke or consume marijuana in federally subsidized housing or on any federally owned land in the State of Nevada.

### **7. Can I sell marijuana that I purchased from a retail marijuana store?**

No, it is illegal to sell marijuana to another person. Only licensed retail marijuana stores may sell retail marijuana to persons that are at least 21 years old.

### **8. Can I grow marijuana at home?**

You cannot grow your own marijuana at home if you live within 25 miles of a retail marijuana store (unless you are a medical marijuana cardholder – those rules are different)

### **9. Can I travel to another state with marijuana?**

No, marijuana is still an illegal drug under federal law and transportation of marijuana or marijuana products across state lines is illegal.

## **CULTIVATION / PRODUCTION FACILITIES**

**10. If I am already licensed as a medical cultivation facility or a medical marijuana production facility do I have to apply for a state and local license for retail cultivation or production?**

Yes. You must apply for and obtain a state license and a local business license in order to cultivate retail marijuana or produce retail marijuana products.

**11. Can I transport or deliver marijuana or marijuana products to other marijuana establishments?**

A cultivation facility may transport marijuana to another cultivation facility, to a production facility or to a testing facility, but not to a retail marijuana store. A production facility may transport marijuana to or from a cultivation facility, another product manufacturing facility or a testing facility, but not to a retail marijuana store. A testing facility may transport retail marijuana and marijuana products to or from any retail marijuana establishment. However, only a licensed marijuana distributor may transport marijuana or marijuana products to a retail marijuana store for sale.

## **TESTING FACILITIES**

**12. If I am already licensed as a medical testing laboratory do I have to apply for a state and local license for retail testing facility?**

Yes. You must apply for and obtain a state license and a local business license in order to provide testing services for retail marijuana or retail marijuana products.

**13. Can I transport or deliver marijuana or marijuana products to other marijuana establishments?**

Yes, a testing facility may transport marijuana or marijuana products to any from any other marijuana establishment.

## **RETAIL MARIJUANA STORES**

**14. If I am already licensed as a medical marijuana dispensary do I have to apply for a state and local license for a retail marijuana store?**

Yes. You must apply for and obtain a state license and a local business license in order to sell retail marijuana or marijuana products.

**15. Can I transport marijuana or marijuana products from a cultivation facility or a production facility to my retail marijuana store?**

No. Only a licensed marijuana distributor may transport marijuana or marijuana products from a cultivation facility or a production facility to a retail marijuana store (even if the facilities are located at the same address).

**16. Can I deliver marijuana or marijuana products to a customer at their residence or hotel room?**

You may deliver marijuana and marijuana products to a customer at a residence as long as you comply with the provisions in LVMC 6.95.

**17. If I am not already licensed as a medical marijuana establishment (Testing, Cultivating, Selling, or Producing) can I apply for a recreational marijuana license?**

No, currently only those who hold a medical marijuana establishment license may apply to operate a recreational marijuana establishment.

## **MARIJUANA DISTRIBUTOR**

**18. As a Marijuana Distributor can I transport or deliver marijuana or marijuana products to customers?**

No, a marijuana distributor may only transport marijuana or marijuana products between licensed marijuana establishments.
