## **CHECKLIST/INSTRUCTIONS - TEENAGE DANCE HALL**

### **DEFINITIONS:**

#### LVMC 6.80.020

**Teenager** - a minor person who is between the ages of thirteen years and nineteen years.

Teenage Dance - is any public dance which primarily teenagers are invited, whether admission thereto is by a set admission charge, by the donation of money or is at no charge.

Teenage Dance Hall - is any place in which dances that are attended primarily by teenage persons are regularly held or conducted, whether admission thereto is by a set admission charge, by the donation of money or is at no charge.

Teenage Entertainment Location - is any place at which a teenage dance is conducted or a teenage dance hall or a teenage nightclub is operated and for which a license is required by subsection (A) of LVMC Section 6.80.030, and includes without limitation any parking area that is required by LVMC Section 6.80.090.

Teenage Nightclub - is any establishment in which primarily teenage persons regularly gather, either to participate in dancing or to observe live entertainment, whether admission is by a set admission charge, by the donation of money or is at no charge.

application.
