**AUTHORITY:** Nevada Revised Statutes (NRS) 354.59891, Senate Bill No. 184 and City of Las Vegas Resolution R-33-2006

**TERM:** 2 Years  
No limit to number of terms  
No City Residency Requirement

**APPOINTED:** 5 Members recommended by the City Manager and approved by the City Council. The five members shall represent the following categories:

- Residential Construction Industry
- Commercial Development Industry
- Construction Industry
- A Public Officer who manages fiscal affairs for the City of Las Vegas
- A Public Officer of the Department of Building and Safety for the City of Las Vegas who oversees directly the operation of the Enterprise Fund

**MEETINGS:** Must meet at least twice per fiscal year, and additionally at the call of the Chairman.

**NOTES:** Members may name alternates from their respective organizations.

**PURPOSE:** Review the operation of and make recommendations relating to the Enterprise Fund.
