**AUTHORITY:** Created by Council action on August 4, 2010 (Item 45). Memorandum of Understanding between the City of Las Vegas, the City of Las Vegas Redevelopment Agency and the Culinary Union to create a committee to act in an advisory capacity and provide input to the Redevelopment Agency on proposed projects and programs within the Redevelopment Area approved 8-4-2010 (Item 37). Committee By-Laws adopted by the City Council on August 4, 2010.

**MEMBERS:** 9 members

**TERM:** 3 years. Initial terms are staggered with 1, 2 and 3 year initial terms. Categories 7, 8 & 9 are initial 1 year terms; Categories 4, 5 & 6 are initial 2 year terms; and Categories 1, 2, & 3 are initial 3 year terms.

No member may serve more than 2 full consecutive three year terms. (Filling any portion of an unexpired term does not count towards the 2 full terms) Must fill unexpired terms if appropriate.

**CATEGORY G – THREE COMMUNITY MEMBERS (resides or works in the Redevelopment Area within Wards 1, 3 and 5)**
