**AUTHORITY:**

Created by Council Action on 3-9-98 with bylaws approved on 6-22-98. By-Laws were amended on 2-16-2000 to increase the membership to 13 members. By-law approval of 3-18-2009 adjusted terms to April 1 through March 30 of appointed year; By-Laws were amended 5/19/2010 to clarify City residency is not required.

 Mayor or her/his designee  
 Council Liaison or Staff Designee of the Councilmember for each of the six Council Wards  
 One Neighborhood Representative for each of the six Council Wards

**NEIGHBORHOOD PARTNERS FUND BOARD**

- TERM:** Members shall each serve a term of one year. Expiration dates were set on 5/18/2000 so all members terms expired at the same time and adjusted to 4/1 to 3/30 in 2009.  
Members may be reappointed to consecutive one-year terms as necessary  
(Must fill unexpired term. Membership is not assignable or transferable.)
- NOTES:** Members Need Not Be City Residents
