THE EVENT ALLOWS THE COMMUNITY TO COME TOGETHER ONCE A YEAR TO CELEBRATE THE HISTORY OF THE CITY AS IT WAS ASSOCIATED WITH HELLDORADO DAYS, REMINISCE ABOUT PAST EVENTS AND INTRODUCE NEWCOMERS TO THE EVENT.
