

What is Our Future East Las Vegas plan?

Our Future East Las Vegas is a multifaceted vision for Ward 3 consisting of various initiatives aimed at bringing economic development, housing options, public infrastructure and services to neighborhoods. The initiatives are all part of the implementation of the 2050 Master Plan.

Who is spearheading Our Future East Las Vegas plan? This campaign and overall effort is managed and administered by city of Las Vegas.

What is the 2050 master plan?

The 2050 Master Plan provides the foundation for future land development, parks accessibility, transportation improvements and job creation in 16 different geographic areas to include the greater area of East Las Vegas.

Some components of the East Las Vegas master plan are already underway and include developing a housing project that will bring affordable and market rate options for housing that also incorporates commercial space, a community center, a workforce training center and park space. This proposed area for this project is on the site of the current Desert Pines Golf Club.

In addition, there is also a focus on neighborhood revitalization known as NRSA, where current efforts are underway. This area is generally bordered by I-515/U.S.95 and Wengert Avenue from north to south and Bruce Street and Mojave from west to east.

Does this mean elements of the overall plan won't get started until 2050?

The goal of the 2050 master plan is to establish a vision for the future, and act as a guide for policy recommendations and physical improvements in the years to come.

What are the core components of Our Future East Las Vegas plan?

The vision for Our Future East Las Vegas is to develop and maintain an equitable, resilient, healthy, livable and innovative community and do so by respecting the history of the area and ensuring residents are not displaced or unintentionally hurt by these improvements.

How is the final plan for east Las Vegas decided?

As the process moves forward, many ideas and concepts from community input will be shared, developed and adopted into the plan. With the ultimate goal that the plan be implementation-focused, relevant, clear and adaptable to change.



How can one provide input for Our Future East Las Vegas plan?

Members of the community can take the Our Future survey by visiting lasvegasnevada.gov/ourfuture (or lasvegasnevada.gov/nuestrofuturo) as well as participating on upcoming facebook live conversations and participating in an activity at outreach events in the area. The survey is available in both English and Spanish.

What efforts are going into ensuring quality survey input?

The city has created an Our Future East Las Vegas campaign utilizing billboards, advertising social media, community event outreach, face to face meetings and other marketing tactics. The goal is to ensure public involvement is inclusive and transparent and outcomes are broadly supported by community consensus.

What is the timeline for Our Future East Las Vegas plan?

Survey input will continue to be collected throughout the summer with vision alternatives explored based on feedback in the fall and recommendations and strategies from the surveys introduced by the end of the year accompanied by next steps and metrics. The community can expect to see a plan by the end of 2022.

When will the plan be implemented, once the plan is finalized?

The goal is to begin implementation of parts of the plan immediately; some recommendations may be easier improvements or possible changes. Others may be major projects and may take years to complete and may depend on funding or other factors.

What is a Neighborhood Revitalization Strategy Area (NRSA)?



The Neighborhood Revitalization Strategy Area or NRSA for short, is a special designation through the U.S. Department of Housing and Urban Development (HUD) that would allow the city of Las Vegas to target Community Development Block Grant (CDBG) resources in support of the community revitalization efforts. The specific area which is currently going through its own neighborhood efforts are generally bordered by I-515/U.S.95 and Wengert Avenue from north to south and Bruce Street and Mojave from west to east.
