#### INTRODUCTION

Natural beauty, cultural diversity, and creativity are just a few qualities that make Las Vegas famous. Our public art embraces and reflects those qualities. The city of Las Vegas Public Art Program advocates for the arts as a vital part of daily life and supports investing in a vibrant arts community through the commission of artwork located throughout the city. Public art is critical to strengthening districts and neighborhoods.

#### **MISSION**

- Integrate public art into city of Las Vegas infrastructure and facilities.
- Leverage the talent of local, national, and international artists, designers, and fabricators to create works of art in Las Vegas.
- Provide public awareness of the value and benefits of the arts.

#### **DESCRIPTION**

The city of Las Vegas, Public Art program wishes to commission artists or teams of artists to create original works of art for the Las Vegas Medical District (LVMD). The LVMD is a collaborative effort between the city of Las Vegas and the downtown Las Vegas medical and health care community. The LVMD creates an environment that supports future and continued development of businesses and real property within the district. The goal is to further the availability of services complementary to current medical providers, build on the sense of community and enhance the quality of health care for all southern Nevada.

#### **GOALS**

The Las Vegas Medical District Public Art Plan aims to create a connection between the city of Las Vegas and the downtown medical and health care community. The commissioned works of art will generate an interconnected visual representation that unites the area and celebrates a thriving medical and health care community.

#### **BUDGET**

The Las Vegas Arts Commission allocated \$436,000 from the Percent for the Arts Fund on September 15, 2022. The Las Vegas City Council approved of the Fiscal Year 2023 Municipal Arts Plan at the November 16, 2022 meeting, which included this project.

Additional Capital Improvements Project Funds have been allocated by the Office of Ward 1 in the amount of \$236,550 in order to complete the proposed projects listed on page 2.

Radiation Oncology Center Parking Lot Mural	Possible mural on privately owned exterior building wall at the Radiation Oncology Center, 624 S Tonopah Dr, parcel no. 13932705009. Property owner approval would be needed.
Medical Office Building Mural	Possible mural on privately owned exterior building wall at the Medical Office Building, 700 Shadow Ln, parcel no. 13933412002. Property owner approval would be needed.
Parking Garage Mural	Possible mural on privately owned parking garage located at 701 Shadow Ln, parcel no. 13933402001. Property owner approval would be needed.
Alta & Tonopah Properties	Possible public art on city of Las Vegas owned parcels no. 13932704004, 13932704003, 13932704002. Potential site of private development.
Charleston & Shadow UMC Corner	Possible public art on city of Las Vegas owned parcel no. 13933499091. Current site of extensive updates to signage and right-of-way.
Median Art	Request to include public art in roadway medians.
Art on Sidewalks	Request to include public art on sidewalks, similar to Main Street.
Placement of Restored Neon Signs	Request to include restored neon signs from the Neon Museum within the area.  This project is in progress, though not considered public art and therefore not further included within this document.

#### **FOCUS GROUP SUMMARY**

A *Medical District Art Focus Group* meeting was held in September 2022 with participants: Dean Marc Kahn, Councilman Brian Knudsen, Dr. Annie Weisman, Kathi Pauli, Tabitha Pederson, Maria Jose Trevino Espinosa, Danita Cohen, Shana Tello, Dorian Stonebarger, Zaria Reyes, Santosha Veeramachaneni, Natalie Johns, Emily Weinschreider, and Dr. William Johnson. Participants were asked to respond to the following question: *What do we want the medical district to feel like?* Below is a summary of their responses, which has been used to guide the development of each Public Art Project scope within the Medical District.

PROJECT	DESCRIPTION
Feelings	Calm, eclectic, thriving, cocooned, all senses engaged, sense of belonging, safe
Activities	Sitting, reflecting, playing, working, running, living, meditating, meditating with the assistance of a QR code, relaxing, re-centering, sound therapy
Emphasis	Mental health, movement of people, women and children's health, safety, interconnectivity
Spaces	Campus for mental health, walkways, interactive, green space, walking paths, strategic event space, healing garden, Zen garden, places to sit, built environment, safety police buttons, shaded areas, device charging areas, pedestrian bridges
Artwork	Sculpture walkways, interactive stethoscope sculpture, art that leads to the main place, the medical staff with one snake, long piece of art, Mexico City sugar skulls, significant pieces of art throughout and connected all together, walking meditation type of poetry walk, cairn rocks, hope letters, donor wall with tiles, Linda Alterwitz integrating science and nature into bus shelters, wind chimes, ocean bowls, photos and nature, requirement for developers to fund public art in the area, sculptures, murals, all mediums of artworks, lights as art installations, patterns replicated in nature and anatomy, bright colored murals by local artist, representation of minority groups in art
