I understand that subsidy assistance registration fee has not been paid.	I understand that subsidy assistance is <b>not</b> applicable towards the program Registration Fee. Services will be denied if the required registration fee has not been paid.		
	I understand my subsidy discount is only valid within my authorized care date range <u>and</u> is only applicable as of the date my certificate is processed by the Safekey office. <b>Subsidy discounts will not be applied retroactively</b> .		
I understand it is my responsibility to submit an updated certificate <u>prior to the expiration date of the current certificate</u> to avoid any gaps in subsidy coverage dates. Updated certificates will not be applied retroactively, regardless of the certificate authorized care dates.			
I understand I must pay <b>full price</b> fo	or days used during any gaps in subsidy coverag	e.	
coverage dates overlap multiple sch	I understand I must sign a new Safekey Child Care Subsidy Acknowledgement Form with every new school year. If my subsidy coverage dates overlap multiple school years, I must submit (or re-submit) the latest version of my certificate, and a new acknowledgement form at the start of the next school year before my subsidy can be reapplied to my account.		
certificate coverage. Once my certi	I understand that based on the terms of my subsidy certificate, my child's Safekey services may not be fully covered based on certificate coverage. Once my certificate has been processed by the Safekey office, I will receive an email to the main email addres listed on my Safekey account, notifying me when my certificate has been processed.		
Unreimbursed fees will be placed a	I am required to pay any portion of fees for services used which are not reimbursable or that are denied by the subsidy organization Unreimbursed fees will be placed as a balance on my account. If I fail to pay the balance, my Safekey services may be suspended/account frozen until the payment has been made.		
I understand that subsidy organizations do not reimburse providers for dates a child does not attend. Therefore, I must remove any scheduled dates on my child's calendar if he/she will be absent. Otherwise, I will be responsible to pay full price for the program spot reserved for my child on that day.
