In addition to the waiver and release set forth herein, the undersigned, as the Participant, or as the parent or legal guardian of the Participant, agrees to defend, indemnify and hold the City, its officers, employees, agents and representatives, harmless from any and all claims, demands, suits, judgments, awards or any other form of liability for personal injuries and/or property damage, which is the result of the Participant's negligent act or omission in connection with the Participant's participation in any of the aforementioned events or programs administered or sponsored by the DEPARTMENT OF YOUTH DEVELOPMENT AND SOCIAL INNOVATION, or use of any facility owned by the city of Las Vegas in connection therewith.
