Instructions for Sealing Pardoned Charges

NRS 179

This packet contains five sections:

Instructions, Request 7orm, Petition to Seal Pardoned Charges, Declaration and Verification, and Order to Seal Pardoned Charges

NOTE: This form may only be used to seal ardoned charges. Charges that were not pardoned may not be included and including non-pardoned charges will result in a denial.

Instructions

- 1. Acquire a **certified** copy of the pardon.
- 2. Fill in the two page request form. This form must be completed on the computer and cannot be handwritten it inserts information into the text of the Petition and Order. If you have questions about filling in the or if you are unable to fill in the form at a computer, please contact us at: 702-229-2235.
 - a. A red asterisk (*) means the information is required.
- 3. Make sure the information you entered is correct and complete.
- 4. Click the PRINT button found at the bottom of page 3. (The first page of instructions will not print.)
- 5. Sign and date the following:
 - a. The 2nd page of the Petition to Seal Pardoned Charges, on lines 26 and
 - b. The Declaration and Verification, on either line 14 or line 21.
 - c. The 2nd page of the Order to Seal Pardoned Charges, on line
- 6. Acquire a self-addressed stamped envelope.
 - a. If you do not have a mailing address, please contact us at 702-229-2235.
- 7. Send the signed documents, the certified copy of the pardon and the self-addressed stamped envelope to Las Vegas Municipal Court. You may either mail it or drop it off.

What to Expect

Las Vegas Municipal Court will review the packet.

If there are any issues, you will be contacted and the packet may be returned to you for corrections.

If there are no issues that need to be corrected and the charges listed are included on the Pardon, the Judge will sign the Order and the Court will seal the charges in the Las Vegas Municipal Court.

Las Vegas Municipal Court will forward a copy of the Order to the Las Vegas Metropolitan Police Department.

Three certified copies of the Order will be returned to you, along with a compliance letter stating the charges were sealed in the Court's system. (Additional copies may be purchased; please see the request form at the bottom of the next page.)

You must then send copies of the Order to any agency that has record of the sealed charges.
