Funding is available for the following grant programs:

Community Development Block Grant (CDBG) – **Public Service Only**Housing Opportunities for Persons with AIDS (HOPWA)

Priority consideration and funding will be given to applications addressing:

- Homeless prevention and intervention services with a preference towards families with children, seniors, singles with non-custodial children and street homeless;
- Health Services to address physical, behavioral and mental health needs;
- Youth programs that focus on academic skills and early childhood development;
- Employment Training to increase self-sufficiency;
- Housing activities and related supportive services to address housing stability for individuals with Acquired Immunodeficiency Syndrome (AIDS).

Applicants must be certified 501(c)(3) or 501(c)(4) nonprofit organizations; have been in business at least one year prior to the application release date; identified as active and in good standing with the Nevada Secretary of State office; and properly licensed by the city of Las Vegas Business License Department to perform services identified in the application at time of application submission. The deadline for submitting completed applications is Thursday, Nov. 13, 2025, at 3 p.m. PST. Applications will not be accepted after this deadline. Applications will only be accepted through Neighborly.
