FRIDAY, SATURDAY AND SUNDAY FLAT RATE:

**Capacity Up To 550 People\$2,250

Deposit \$500 refundable

*For additional hours use hourly rate \$450.

**Portable restroom rental required.

LAKESIDE COURTYARD + COURTYARD GAZEBO

Includes two hours of park special event time. Additional hours may be purchased as add-ons*.

MONDAY - THURSDAY HOURLY RATES (AND/OR WEEKEND ADD-ONS):

Capacity Up To 275 People\$600

Deposit \$100 refundable.

For additional hours use \$300 hourly rate

RANCH HOUSE:

\$150 Hourly Rate add-on to Park Special Event Permit

ADDITIONAL FEES:

- \$200 Cleaning Fee as determined by Special Events Staff in After-Event Inspection Report.
- \$150 Fine for non-permitted use of bicycles, skates, skateboards and hover boards.

CANCELLATIONS:

- Park facility use reservations cancelled with more than 30 days in advance of the event will be reimbursed the rental fees received to date, including the \$500 deposit.
- Cancellations occurring less than 30 days in advance of the event will be reimbursed the rental fees received to date, excluding the \$500 deposit.
- Both rental fees and the deposit are nonrefundable if cancelled within seven calendar days prior to the event start date.
- Approved refunds will take approximately 2-4 weeks to be processed.

NOTES:

- The Hay Barn and Courtyard Gazebo are available for set up at 8 a.m. the morning of your event. Events must end by 7 p.m. in the summer or 4 p.m. in the winter. **For weddings:** one hour of rehearsal time up to seven days prior to the ceremony is included in the daily, flat rate.
- Prices are subject to change based on addition of amenities such as restrooms, tables/chairs and other accommodations.
- Rental fees do not include insurance, food or beverage service, facility set up, equipment rental (including AV equipment), decorations, transportation, multi-vendor permits, security or entertainment.
- Event Holder must sign off on both the Park Special Event Policies Handbook and the Hay Barn Rental and Use Agreement.
